Since then, thousands of young people have benefited from the opportunities to make music as individuals and in a wide variety of small and large ensembles. From 3-year-olds through to university and conservatoire entrance, our aim is to encourage a lifelong passion for music and to give our students the opportunities to develop to their maximum potential.

We invite applications for the posts available, to join our vibrant and thriving department in the stunning location of King Charles Court at the Old Royal Naval College, Greenwich.

The post holder will be responsible for delivering individual lessons to students aged between 5 and 19 years of age, from beginners to diploma level. The post requires working as an individual teacher but also as part of a wider team within our programme for under 11s and our Main Programme faculty, with the possibility of group work as and when required. Post holders will be expected to commit to 30 teaching weeks of the year, plus Staff Development morning at the start of the academic year. The position requires the post holder to be available for a full day every Saturday, although exact teaching hours are confirmed on an annual basis.

Please note: This position involves working with children & young people and vulnerable adults therefore all appointments will be subject to an enhanced Disclosure & Barring Service check. PURPOSE OF ROLE:

To be responsible to the Head of Junior Trinity for the successful musical education of students between ages 5 - 18, in accordance with the requirements of the Junior Trinity curriculum. To effectively guide and support students to progress and reach their potential.

MAIN DUTIES:

TEACHING AND LEARNING

- *To develop and to disseminate examples of good practice in teaching, learning and assessment.*
- *To ensure that personal skills and knowledge are maintained in such a way as to be relevant to the students' needs and the syllabus outcomes and content.*
- *To give all students clear information about the relationships between achievement, progress and assessment and to ensure that they are aware of the requirements of the current curriculum and any examination syllabuses, where relevant.*
- *To keep detailed and up-to-date records on student progress and attendance.*
- *To contribute to procedures for regular appraisal to ensure the effectiveness of teaching, learning and assessment strategies.*
- *To prepare appropriate and effective lessons to support the delivery of any Junior Trinity curriculum.*

- *To discuss potential repertoire and programming with the management team of Junior Trinity throughout the year, and to provide requests for music hire in a timely fashion*

STUDENT SUPPORT AND DEVELOPMENT

- *To foster systems and methods which ensure that students are empowered to take personal control of their own development, by providing opportunities for the exercise of choice, decision making and responsibility within a supportive environment, to promote the development of autonomous learning.*
- *To advise the Lead Tutor Head of any student whose work, or attendance, or wellbeing gives cause for concern.*
- *To offer students educational guidance on the assumption of equality of opportunity for all students.*

STUDENT ASSESSMENT

- *To implement assessment criteria and procedures for the curriculum, as required by the Lead Tutor Head*
- *To supply marks and reports to the Lead Tutor Head as and when required.*
- *To cooperate fully with the requirements of any board of examiners and/or assessment panel.*

- *To contribute to the preparation of publicity material, as requested.*
- *To contribute to the preparation of entrance/interview/audition tests or assessments as required.*
- *To contribute to the processes of interviewing and auditioning candidates, as required.*
- *To provide information for timetabling, as required.*
- *To attend any meetings or staff development activities related to the duties described above, as agreed with the Lead Tutor Head.*
- *To undertake institutional online training modules as required*
- *To keep under review the provision of human and physical resources used and to advise of any modifications that may be required.*
- *To ensure that personal leave is taken at times which do not conflict with the efficient discharge of the above duties.*
- *To be familiar with all the Conservatoire's rules, regulations and procedures.*
- *To be familiar with current Safeguarding legislation relating to children and young people.*
- *To undertake such other related duties as the Lead Tutor Head may reasonably require.*
