## PURPOSE OF ROLE

The Intern will assist Learning & Participation (Music) team in the management of Junior Trinity, Trinity Laban's Saturday programme for over 400 young musicians aged 3 - 19. The Intern will be involved in the planning, organisation, day-to-day management and implementation of the Junior Trinity programme.

Established in 1906, Junior Trinity is the oldest junior department of a UK conservatoire. It includes the following programmes:

- Band Time and String Time: Junior Trinity's programmes for children aged 3 11, encouraging young players to embark on their musical journey through ensemble performance and creative learning.
- **Main Programme:** Taught over 30 teaching-weeks in each year, Min Programme students receive individual instrumental and ensemble tuition and musicianship, and take part in choirs, large and small ensembles. It also includes a programme of concerts, workshops and masterclasses throughout the year.
- **GCSE and A Level:** Our Main Programme students have the opportunity to follow a series of one and two year academic courses leading to GCSE and A-Level qualifications in Music and Music Technology
